1. **GENERAL**

The 40th Annual Gathering / 13th AIBD General Conference & Associated Meetings to be held from 13 to 15 August 2014 in Phnom Penh, Kingdom of Cambodia.

3. CONFERENCE REGISTRATION

Registration for delegates will be open from **Monday**, **12 August 2014 at 09:00** onwards. You are kindly requested to collect your conference bags/documents from the AIBD and the Organising Committee Secretariat from **12 August 2014** onwards.

4. HOTEL ACCOMMODATION & CANCELLATION CHARGES

CHECK- IN TIME : 15:00 HRS CHECK – OUT TIME : 12:00 NOON

A. AMENDMENT OF ROOM RESERVATION

Amendment of room reservation must be received by the hotel at least 5 days prior to guest's arrival, and must include arrival time and meal requirements (if any). The hotel reserves the right to release all rooms if this requirement is not met within the time stated.

B. PAYMENT

All charges on guest's personal account should be settled upon departure in cash or VISA or Master card without surcharge. Hotel may request a deposit from guests on arrival to cover the approximate stay expense.

Should your company wish to settle guest stay bill, a written authorization to hotel is requested.

C. CANCELLATION & NO SHOW POLICY

In case of amendment or cancel of any confirmed booking, modifications **must be made 72 hours prior to arrival date**, <u>otherwise hotel will collect one night charge</u> as late amendment or cancellation fees as per hotel policy. In case of no show, hotel will charge one night charge as per hotel policy.

5. <u>IMMIGRATION REQUIREMENTS</u>

All delegates must hold passports that are valid for at least six months beyond the time of their arrival in Phnom Penh. Visa exemption is granted to all nationals from ASEAN Member States during their stay in Cambodia less than 30 days. Other delegates can have visa on arrival. It is also advisable that delegates could obtain appropriate entry visas to Cambodia from Cambodia's diplomatic or consular mission at their point of origin.

VISA ON ARRIVAL

To grant or not to grant visa is the right of Cambodian Government:

All powers to grant or not to grant visa to any foreigner shall be vested in the Royal Government of Cambodia.

6. CUSTOM REGULATIONS

Narcotic drugs as well as arms and ammunition may not be brought into Cambodia; they are strictly prohibited. Offenders are subject to strict and severe punishment in line with local laws and regulations.

7. HEALTH

Basic medical services are available at the hotel. Immunization certificates are not normally required for entry into Cambodia. In the event of a medical emergency during the GC, please contact the AIBD or Host Secretariat who will facilitate transport to the nearest hospital. Delegates are requested to have sufficient medical insurance as any emergency medical care will have to be paid directly by the delegates.

8. FOREIGN EXCHANGE AND CURRENCY

The exchange rate is approximately 1USD = (+) 4000 Riels (Cambodian currency). Foreign currencies are exchangeable at the commercial banks, airport, and money changers or at the Hotel. Bank notes are available in denominations of most commonly used 100, 500, 1000, 2000, 5000, 1000, 2000, 50,000 and 100,000 Riel.

9. AIRLINE AND FLIGHT INFORMATION

Many international airlines operate regularly and directly services to and from Phnom Penh. Delegates are advised to secure their return bookings prior to their departure from Phnom Penh. If this is not possible, they should make firm return bookings immediately upon arrival in Phnom Penh. Delegates can liaise directly with the Hotel's Business Centre or the host's liaison officers. Please check with nearby travel agency for the schedule of flights.

10. AIRPORT TRANSFER

The Host will provide local return airport-hotel transfers to all delegates during their arrival and departure.

11. WEATHER

In Phnom Penh, August is monsoon month with temperatures averaging approximately 32 degree Celsius. Temperature will be maintained in the conference room where the meetings are to be held.

12. INTERNATIONAL DIRECT DIALLING

Phnom Penh is linked via satellite to all major countries of the world. International call can be made from any private cellular phone companies or hotel phone. Delegates may find the local sim cards with the present of passport.
